DECLARATION OF ASATUR SHISHIKYAN

I, ASATUR SHISHIKYAN, declare as follows:

1. I am Mher Hakopyan's (the "Defendant") cousin and surety in a Case known as USA v. Hakopyan, et al, case Number SACR12-145-CJC.
2. I read, write and understand English.
3. The Defendant is currently released on bond and is under intensive pretrial supervision and GPS monitoring.
4. It is my understanding that the Defendant wishes to have the GPS monitor removed and that he is also seeking to eliminate the requirement that he participate in the home detention and pretrial electronic monitoring program.
5. I have no objection to the Defendant's request.
6. I am still willing to remain his surety even if the GPS unit is removed and he is not participating in the home confinement program monitored by the United States Pretrial Services office.
