Re: Craigslit, Inc. advertising of Prostitution Services


Dear Mr. Kirkconnell:

No response from Craigslit, Inc. has been received regarding the letter dated January 10, 2008, sent via certified mail from the Metropolitan Bureau of Investigation to you, Craigslit Counsel Edward Wes, Craigslit CEO Jim Buckmaster, and eBay CEO Meg Whitman. Accordingly, it appears that Craigslit, Inc. is not interested in working with law enforcement to amicably resolve this nationwide problem of the Craigslit *Erotic Services* section promoting prostitution.

The Metropolitan Bureau of Investigation has attempted to work with Craigslit, Inc. to resolve this problem outside of the Criminal Justice System but, so far, these efforts appear to be a futile attempt to gain cooperation and corporate responsibility from Craigslit, Inc. You may already be aware that the Metropolitan Bureau of Investigation has recently resolved a similar issue in the Criminal Justice System involving a local weekly print publication charged with Racketeering, which has now agreed to stop publishing an advertising category that was aiding and abetting prostitution.

If the appearance that Craigslit, Inc. is avoiding further efforts on this issue is inaccurate, please forward your response, via certified mail, to the Metropolitan Bureau of Investigation by March 28, 2008. Hopefully, Craigslit, Inc. will demonstrate good corporate citizenship by putting an end to the practice of illegal interstate commerce by Aiding and Abetting the prostitution industry.
