STIPULATION

19 Defendant Eric Omuro is presently free on bond under conditions of release imposed by
20 the Court. One of those conditions is that Mr. Omuro not access the Internet, either directly or
21 indirectly. Having met and conferred, the parties agree and stipulate this condition should be
22 modified as follows:

23 The defendant shall not access any of the websites listed in the supplement filed by the
24 government on July 1, 2014 (Docket No. 10). The defendant shall not access, develop, or
25 contribute to any other websites that purport to provide escort services, massage services, strip
26 club reviews, or related services. The defendant may access the Internet for all other lawful
27 purposes, including but not limited to funding counsel, assisting in his legal defense, managing

14 By stipulation of the parties, and for good cause shown, defendant Eric Omuro's
15 conditions of release are modified as follows. In lieu of the current condition prohibiting Internet
16 access, defendant Omuro shall comply with the following condition:

17 The defendant shall not access any of the websites listed in the supplement filed by the
18 government on July 1, 2014 (Docket No. 10). The defendant shall not access, develop, or
19 contribute to any other websites that purport to provide escort services, massage services, strip
20 club reviews, or related services. The defendant may access the Internet for all other lawful
21 purposes, including but not limited to funding counsel, assisting in his legal defense, managing
22 and paying bills, online shopping, emailing friends and family, accessing social networks, playing
23 games, and locating and facilitating verifiable employment.

24 All other conditions of release shall remain in effect.
