I advised the actor that he was identified s the actor of this complainant and he will be arrested for this complaint. He was advised of his Rights and ated here at the Robbery Squad by Unit #412 (P/Os R. Oliveras & M. Cancel) for this complaint of ggravated Assault.

Orange Ave. & So. 19th St. When I saw him I pointed him out to the East Orange Officers and they was getting ready to grab him but I got scared because it was a lot of people out there and I didn't want them to see my face. It's common knowledge that people were out to kill Kemo because of what he was doing.

How well did you know Kemo?
